Council Minutes

Alleman City Council met Monday February 10, 2020 at 7pm in City Hall. Mayor Pro Tem Jones called the meeting to order at 7:00 pm. The Pledge of Allegiance was recited. Mayor Pro Tem Jones asked for a roll call. Council members present: Arlene Sampson, David Wilcox, and Perry Smith. Mayor Kramme was telecomfranced in.
